The "OPAA Master Class 2013/2014 – Forum" held on 29 November 2013 successfully attracted over 350 students, staff and alumni for the sharing from four outstanding PolyU alumni, including Ir Dr Otto POON Lok-to, BBS; Mr Marco WU Moon-hoi, SBS; Ir Prof. James LAU Chi-wang, BBS, JP; and Ir Vincent TSE Kam-chuen. Ir Dr CHAN Fuk-cheung, Director of the Association, served as the facilitator and led the panel discussion.





After the Forum, the first "Mentors-Mentees Gathering" was held for the "OPAA Master Class 2013/2014 – Mentorship Programme." Twenty-four mentees had the opportunity to meet and chat with some of the mentors of the Programme.
